A word from the President

I was very pleased to be elected BEUC President at our Annual Assembly in Brussels in November 2008. I feel very strongly that it is essential that Europe becomes a Europe that citizens and consumers trust, only in that way will Europe have resonance with its citizens and have a real future. BEUC plays a key role in helping to develop this trust.

The promotion of consumer interests and the protection and strengthening of consumer rights is a key issue in all EU policies. BEUC


faces an increasingly complex task, but we also see the positive outcome of our input on many dossiers.

2008 was a difficult year for Europe's consumers, with the biggest financial and economic crisis in many years in addition to large rises in fuel and food prices. The credit crunch and the near collapse of the European banking system raise many important lessons for national governments, but also the EU.

The deep economic and financial crisis that consumers are living through today, and that they will be dealing with in the years to come, give BEUC more responsibility for ensuring that consumer interests are very much taken into account in the measures being taken now to face up to the crisis, and helping to ensure that it cannot happen again.

The crisis unfortunately also demonstrates that our proposals and requests in the field of financial services such as responsible consumer credit and loans, clearer information on financial products, independent financial intermediairies and advisors were and are well-grounded and very much needed. It also very clearly proves that consumer protection measures are not only in the interest of consumers, but also of the whole society and the economic system.

European institutions must now take urgent action to protect consumers' deposits and investments and ensure that credit continues to be available on fair terms. Consumers with savings need to be confident that their money is safe



during this unprecedented crisis. Consumers who have taken out loans for homes must not have the loan foreclosed due to failings in the system which has not been able to assume its responsibilities.

The European institutions' responsibility regarding consumers must go further than taking into account banks and institutions that are at the edge of bankruptcy. They must also take action to restore responsibility, accountability and transparency to national and European financial markets. Regulation should place consumer protection above market pressure for short-term profit maximisation.

BEUC has increased its membership significantly over the past 10 years. Many of our new members are from the new Member States. In order to have a real impact at EU and at national level, BEUC needs strong and independent national consumer organisations behind it. BEUC's strength and credibility depend not only on the number of its members, but also on their capacity and strength to work on key consumer dossiers at national and EU level. A special effort still has to be made in support of consumers and consumer organisations in the new Member States and also in the candidate and potential candidate countries.

We are thankful for the support that the European Commission provides to BEUC in the context of the training programme TRACE, the Consumer Law Enforcement Forum (CLEF), the programme run jointly by BEUC and International Consumer Research and Testing (ICRT) on building capacity to conduct comparative tests and publish independent information, but there is still a long way to go to ensure that consumer organisations in these countries are in the same position as their counterparts in the other Member States. We hope the European Commission will be willing to continue the important support in this area.

Finally, I would like to thank Rasmus Kjeldahl (Forbrugerradet, Denmark) for his committed work as BEUC President in the past years, as well as the support provided by the BEUC Vice President Breda Kutin (ZPS, Slovenia) and other members of the BEUC Executive.

Introduction by Monique Goyens

The financial crisis has had an enormous impact on citizens across the world. Many of our members were receiving as many as 800 telephone calls a day from consumers worried about their savings, investments, pensions and even homes. BEUC and member financial experts have been in high demand both by the press and by policy makers, to discuss the implications for consumers, give advice and suggest ways forward.


Because the financial crisis took on such a dimension, it would be easy to forget many of the other key issues that we worked on in 2008. But there are many areas of EU policy that affect consumers.

In April 2008, we organised a dinner with Commissioner Neelie Kroes and many MEPs in Strasbourg on collective redress. BEUC has been lobbying for a binding EU instrument to ensure that a judicial group action mechanism exists in all Member States, covering both national and cross-border cases where consumer detriment might occur, and has developed 10 criteria the ideal mechanism should encompass: BEUC's 10 Golden Rules.

The Commission issued an important proposal on food information. To fight increasing obesity levels and the associated health conditions, consumers should be helped to easily make the right healthy food choices when they shop. We have campaigned in favour of an easy tool for consumers to interpret nutrition information, namely by a colour coded information system.

Now that the energy market is liberalised, energy should be provided at fair and transparent prices. We issued a study in October that concluded that BEUC members continue to report problems faced in areas such as security and quality of supply, affordability and access, billing, choice and information.

We shouldn't pay too much for our mobile phone calls and SMSs. We were delighted that the proposals produced by Commissioner Reding following the review of the current voice Roaming Regulation reflect the views put forward by BEUC during the consultation. BEUC wants to see the Regulation continued, with the addition of SMS and data roaming to its scope.



Nor should consumers be threatened to be cut off from Internet access without an intervention by a court. BEUC and our members feel very strongly about this, and campaigned hard against the "graduated response" solution suggested in some countries. This would make Internet Service Providers liable for copyright infringement for their role in passing communications across their networks. Ultimately this would mean that if a consumer was suspected to be infringing copyright he or she could be cut off from access to his or her Internet connection.

Toys and cosmetics must be safe. The new toys Directive agreed at the end of 2008 will bring some improvements to the safety of children in Europe, but we remain worried about hormone disrupting chemicals that will still be allowed in toys despite the potential risks to children's health. It is also disappointing that most toys will still not have to be checked by an independent third-party before being placed on the market.

We strongly criticised the moves by DG Enterprise to amend, as part of the pharmaceutical package review, the Directive on Medicines in order to allow pharmaceutical companies to communicate directly to the general public on their prescription-only medicines in the guise of 'patient information'. BEUC especially criticised the risk of potential confusion between advertising and objective information and joined with patients, healthcare, community pharmacists and other organisations in a call to the Council and Parliament to reject these proposals.

Last but not least, in October the Commission issued a proposal on consumer rights. This is the long-awaited proposal on the review of key consumer legislation in the area of contracts, the so-called consumer acquis. Effective EU consumer protection legislation, set at a high level as required by the Treaties, is essential for both consumers and the Internal Market. The Commission's proposal for a Consumer Rights Directive (replacing the Directives on Sales and Guarantees, Unfair Contract Terms, Distance Selling and Door to Door Selling) has far-reaching implications for consumers, and responding to it has been a major priority for BEUC.

In short, 2008 has been an important and busy year for the BEUC Secretariat and members. After a consultation with members at the beginning of 2008, it was agreed that BEUC would be focusing on the issues that had been identified as key by members. These are now referred to as headlines and are: affordable energy and sustainable consumption, healthy food for

informed consumers, consumer safety, consumer rights in a digital world, consumer contractual rights (the "acquis"), consumer health care, financial services and collective redress.

The Secretariat was reorganised so that each headline is now managed by a team made up of members of the BEUC staff from our different departments (legal & economic, food, environment & safety, health, and communications). These teams also include four experts from our members, who bring to the BEUC strategy their in-depth knowledge of issues, their experience with consumers (the reality check) and their various national cultures and perspectives.

These teams have been responsible for developing strategies and annual working plans in each of their areas making use of each others' knowledge, perspective and experience. The aim of this way of working is to ensure that we are more active in these key areas, and have more resources available to meet with the various policy audiences and stakeholders at moments that require intensive lobby and media activities. We feel that this new way of working is already leading to concrete results, and next year, our annual report will be focussing on the achievements reached.

We were sad that Cornelia Kutterer, the Head of our Legal Department, and Caroline Hayat, Head of Communications left BEUC in the course of 2008. Cornelia ensured that BEUC gained an enormous amount of expertise in digital and IP areas, while Caroline ensured that BEUC became an effective and creative communicator towards Brussels media and policy audiences.



Introduction

Highlights

With the public focus this year very much on the economic and financial crisis, it would be easy to lose sight of the initiatives taken by BEUC in other key areas. To highlight just a few:

- ★ Our campaign for group action (right to act collectively in court) and private enforcement of antitrust rules.
- ★ Our continuing campaigns in the fight against obesity and for better food information, with a successful event in the European Parliament.
- ★ Our drive to strengthen the Toy Safety Directive and improve market surveillance following the recalls of dangerous toys of the previous year.
- ★ Our campaign against proposals for disproportionate sanctions against Internet users.
- ★ Our fight to ensure that consumers get relevant, independent, and unbiased information about health.
- ★ Our work on the consumer experience of energy markets, leading to initiatives to increase the accuracy, transparency and comparability of energy invoices.
- ★ Our influence in the debate over energy labelling and the importance of effective schemes that are understood by consumers.
- ★ Our major influence and expertise in the debate over privacy and the use (and abuse) of Radio Frequency Identification (RFID) technology and in the debate on the Internet of Things.
- ★ Our successful efforts to prevent changes that would have allowed imports from the US of chicken not subject to the tougher rules on food hygiene operating in the EU.

Communications and campaigns

Presidency and the Council

In June BEUC and its French members met Luc Chatel, the French Secretary of State for Industry and Consumer Affairs, to present a memorandum setting out eight key consumer priorities for the French Presidency of the EU, together with 100 concrete proposals for building a Europe for Consumers. In December, we updated the memo for the incoming Czech Presidency, focusing particularly on the challenges of the economic and financial crisis for consumers.

European Parliament


We have again worked closely with the Parliament, briefing MEPs and suggesting amendments on key issues. As well as liaising individually with MEPs, we have organised a number of successful events in the Parliament including a dinner on group actions at which Commissioner Kroes spoke about her White Paper on Damage Actions for Breach of EC Antitrust Rules; a lunch event on food information; and a lunch and exhibition on toy safety ahead of the vote in plenary on the Toy Safety Directive .

BEUC is most grateful to all the MEPs who made these events possible and who have worked in support of consumers' interests.

During the year we started a project under the Europe for Citizens Programme (DG Education and Culture) to enable us to raise consumer issues with candidates for the new European Parliament to be elected in June 2009.

Health and Consumer Intergroup

BEUC also works with MEPs through the all-Party Health and Consumer Intergroup, a forum for which we provide the Secretariat together with the European Public Health Alliance. Meetings were held in April on the fight against obesity and in October on patients' rights in cross-border healthcare. Unfortunately, changes to the Parliament's operating rules are making it increasingly difficult for Intergroup meetings to take place: we hope the new Parliament will take a more helpful view.



European Commission

In 2008 as in previous years, BEUC has been in contact with many parts of the Commission. We continue of course to liaise closely with Commissioner Meglena Kuneva, her Cabinet and DG SANCO. We were pleased with the initiatives undertaken by Commissioner Kroes on private enforcement, and the pharmaceutical sector inquiry. We were also able to build up our contacts with Commissioner Reding on roaming, copyright and content on-line, and strengthen our relationships with DG Internal Market through several meetings with Jorgen Holmquist and his staff.

Following the launch of the Commission's register for lobbyists in June 2008, BEUC is now registered. We engaged with the EU Civil Society Contact Group in the context of our registration, participating in the definition of common guidelines and organised a press conference to announce these guidelines. We would now like to see progress towards a common register and binding code for the Parliament, Council and Commission, and one that treats NGOs on a non-discriminatory basis.

Representation and dialogue

As well as our day-to-day contact with the Council, Commission and Parliament, BEUC has taken part in many formal consultative processes including the Commission's European Consumers Consultative Group (ECCG) and its sub-groups on financial services and energy; Commission and Parliament hearings; and meetings of European agencies such as the European Food Safety Authority (EFSA), and the European Medicines Agency (EMEA). We assisted with the coordination of consumer representation in the Commission's agriculture advisory committees. We also participated in the High Level Groups on respectively the Competitiveness of the Chemical Industry and the Competitiveness of the Food Industry.

We have also worked closely with other consumer bodies including our sister organisation, ANEC - the voice for European consumers in standardisation, our colleagues in CI - Consumers International and in ICRT - International Consumer Research and Testing. For the first time in our history, we have engaged into a formal partnership with the International Union of Tenants.

We have increased our contacts with a wide range of other stakeholders. We were able to gather an important number of organisations active in the health sector around our approach towards the pharmaceutical package. Those NGOs included the European Older People's Platform (AGE), the European AIDS Treatment Group (EATG), the European Forum of Primary Care (EFPC), the European Public Health Alliance (EPHA), the European Social Insurance Platform (ESIP), Health Action International, the European Federation of Nurses, European Association of Community Pharmacists (PGEU), European Association of Specialised Doctors (UEMS) and the European Heart Network (EHN).

In relation to food information and the need for front-of-pack labelling of salt, sugar and fat we have worked closely with the European Heart Network and the European Public Health Alliance, as well as with Sainsbury's (UK) and Intermarche (France).

In the financial sector, we had many discussions with the European Banking Sector (EBIC) in preparing the guidelines on switching bank accounts.

In the trade sector, we collaborated with the retail sector (Eurocommerce) in the context of the procedure for renewal of antidumping duties for footwear originating in Vietnam and China.

Transatlantic Economic Council

As members of the Transatlantic Consumer Dialogue, we took part in the Transatlantic Economic Council (TEC), the framework for cooperation on trade, economic and regulatory issues. Issues discussed included the financial crisis, product safety, REACH, intellectual property, and the US campaign against the EU ban on US chlorinated chicken. Together with US consumer organisations, we called on the TEC to include climate change, nanotechnology, consumer digital rights and improving diet and health in its agenda.























Media work and publications

BEUC was quoted over 800 times over the year. It is important to note that it is very difficult to be exhaustive, not only because of the explosion of news websites, but also because of the difficulty of tracking national media that have picked up our press activities through the major agencies. We were quoted on almost 80 different topics, notably on toy safety, information for patients, food issues, the Google/Double Click merger and the Intel case. Our publications during the year included a new brochure on group actions, a leaflet on food labelling, a short document showing inadequate warning labels on toys, and a Christmas card highlighting the need for 'traffic lights' for nutrition labelling.

BEUC matters

General Assembly

Our General Assembly met on 29 and 30 May in Madrid during the 25th birthday of CECU, one of our Spanish members. We also met in Brussels on 13-14 November, when members elected Paolo Martinello (Altroconsumo, Italy) as our new President, together with Breda Kutin (ZPS, Slovenia) as Vice-President and members of the Executive. We welcomed Commissioner Viviane Reding who discussed telecommunications issues with members and Commissioner Charlie McCreevy who spoke about the financial crisis.


The General Assembly has agreed that we should increase our effectiveness by investing more of our joint resources in the areas identified by all as key for consumers, and where we can make a real difference in policy outcomes. This means that we cannot take up all of the many invitations that we receive to respond on a wide range of issues, but it will enable us to manage our limited resources as well as we can to the benefit of Europe's (almost) 500 million consumers.

Our members

BEUC welcomed Potrosac, the Croatian consumer organisation, as a new temporary affiliate during the year. The UK's Consumer Focus, which has replaced the National Consumer Council (a former BEUC member), has also joined BEUC. We have also welcomed the International Union of Tenants as our first partner organisation.

New Member States

We continue to support the capacity-building of consumer organisations in the new Member States. TRACE, or Training Courses for Consumer Empowerment, is an important element of this. We have now trained over 800 representatives of consumer organisations from all over the EU, EEA and an increasing number of candidate or potential candidate countries such as Croatia, Macedonia, Turkey and Serbia. In the course of 2008 new courses have been developed for providing more in depth knowledge for advanced participants focusing on Team



Leadership, Lobbying, Presentations Skills and Media Training, Consumer Redress and Financial Capacity Building.

BEUC was also involved in various Taiex-funded training initiatives focusing on consumer and other civil society groups from the candidate and potential candidate countries. We continue our work with International Consumer Research and Testing on building capacity to conduct comparative product test and publish results either in magazines or on websites. The general quality of most of the articles and publications has improved; this can be seen in the cases of Slovenia, Czech Republic, Romania, Poland.

BEUC continues to provide the Secretariat for the Consumer Law Enforcement Forum (CLEF), which brings together 16 consumer organisations, eight of which are from new or accession states. This is part of a three year project with Commission funding to empower consumer organisations and to help them to play their part in making sure that EU consumer protection rules are effectively enforced in their country, particularly in the new Member States.

Training

Training

Training for consumer organisations

The Secretariat was financed by the German organisation GTZ for a week-long training for consumer organisations and government officials visiting Brussels from the Western Balkans.

In November 2008 the TRACE team together with Test Achats organised a training session for consumer organisations in the Ukraine funded by the UNDP.

Training for the Commission

We welcomed the invitation from DG Markt to BEUC to organise two training sessions for its staff on the Consumer Perspective on Single Market Issues. The aim was to help DG Market staff to understand the approach of consumer organisations and how to integrate consumers' needs in DG Markt's policy-making processes.























Policy issues

Legal affairs

« Consumer Rights Directive

Effective EU consumer protection legislation, set at a high level as required by the Treaty, is essential for both consumers and the Internal Market. The Commission's proposal for a Consumer Rights Directive (replacing the Directives on Sales and Guarantees, Unfair Contract Terms, Distance Selling and Door to Door Selling) has far-reaching implications for consumers, and responding to it has been a major priority for BEUC.

There is a case for greater consistency, but the Directive would represent a fundamental turning point in the EU's approach towards consumer policy and legislation and would decrease the level of consumer protection. It would abandon the 25 year old principle of minimum harmonisation and make it impossible for Member States to keep or to introduce rules which provide better protection. In addition, as the Commission's proposal is not based on a high level of protection, consumers in a number of Member States would lose existing key rights in areas such as faulty goods and bans on pre-payments during the withdrawal period. BEUC called for substantive changes to the directive so that it reflects the best levels of consumer protection in the EU27.

Integrating the consumer interest

Getting the consumer interest included in the wide range of Community policies is essential. BEUC welcomes progress on the Commission's Consumer Policy Strategy for 2007-2013 and in particular the initiatives for horizontal integration of consumer policy into general EU legislation. In our response to DG SANCO's Future Challenges paper, we urged the Commission to be proactive and to seek to influence commercial trends and developments, as well as to respond to them.

We also welcome the Commission's vision for the Single Market in the 21st century which

acknowledges the need for enhanced action in favour of consumers, and we put forward proposals to help bring this about. BEUC commented on the Communication on Services of General Interest which formed part of the Review of the Internal Market and was pleased to note that the protocol on services of general interest had been added to the Treaty of Lisbon. We see this as a first step in the evolution of the EU's policy to achieve high-quality services of general interest throughout all relevant sectors, and we look forward to its implementation.

We were however disappointed with the Commission's consultation on its guidelines for undertaking Impact Assessments and we made proposals for improving consumer and health impact assessments.

Private enforcement and collective redress


76% of European consumers would be more willing to defend their rights in court if they could join a collective action according to the second edition of the Consumer Markets Scoreboard published in January 2009.

BEUC has been lobbying for a binding EU instrument to ensure that a judicial group action mechanism exists in all Member States, covering both national and cross-border cases where consumer detriment might occur, and has developed 10 criteria the ideal mechanism should encompass: BEUC's 10 Golden Rules.

At European level, collective redress is being tackled at different speeds by two directorates general: DG Competition and DG Consumer Protection. For BEUC, this dual approach is not an issue as long as both instruments are coherent and useful to consumer organisations in practice.

Airline ticket sales on the Internet

Some airlines advertise fares which bear little relation to the actual price that consumers have to pay. BEUC welcomed the Commission's report on unfair practices on airline ticket-selling websites. We noted that many of the misleading practises identified by the Commission some months beforehand were still widespread. We called for naming and shaming so that consumers can know which companies do not play by the rules.



Copyright and fair use

BEUC wants to see a fair balance between the interests of copyright holders and users. We strongly opposed proposals to extend copyright protection from 50 to 95 years as it would be unfair to users.

We responded to the consultation on private copying levies, addressing consumer issues such as double payment and alternative licensing. In our response to the consultation on on-line content, we highlighted that digital technologies influence and change the way we think and behave in the modern world. Access to knowledge, communication, online services, e-commerce, cultural content such as music and film extends continuously and changes our economic, social and cultural life. It brings new opportunities but also challenges consumers' rights in the digital environment.

For a digital world and market to function well, it is imperative that the legal and contractual framework is clearly set out. Consumers have clear rights in the digital world not to be eroded by new technology or (unclear and) unreasonable contract terms.

We welcomed the initiative by the Commission to inform consumers about their rights in the digital environment (user guide) but, with consumer rights under continued attack from the copyright lobby, we want to see a regulatory measure to reinforce those rights.

The Internet has become essential in participating in society and political discourse, accessing employment opportunities, education, social, health and government services. In the digital age, excluding citizens from the ability to connect to and communicate on the Internet amounts to cutting off individuals from civic and cultural life.

Throughout 2008 BEUC and our members worked hard to stem the political momentum behind the so-called graduated response. This would make Internet Service Providers liable for copyright infringement for their role in passing communications across their networks. Ultimately this would mean that if a consumer was found to be infringing copyright he or she

would be cut off from access to his or her Internet connection by the ISP, but without the evidence being examined by a court. The ISPs would become the police of the net.

Privacy and security

Most consumers are probably unaware that tiny tags on products and loyalty cards make it possible for retailers to monitor individual buying habits a technology that could even be extended to credit cards. This raises issues of privacy, security and transparency, and BEUC welcomed the Commission's decision to examine the use of Radio Frequency Identification (RFID) technology. We want legislation, and not just a Recommendation, to protect consumers. We also raised issues of e-privacy with the Commission and MEPs.

Economic and financial issues

The financial crisis

The crisis in the financial system is also a crisis for consumers, who are deeply anxious about their future and the security of their personal savings, loans and pension plans and, in some cases, even their homes. It is scarcely surprising that consumers have lost confidence in deposit, credit and investment service providers. That lack of confidence in turn discourages cross-border shopping for financial services and thus undermines the single market.

The main reason for the financial crisis lies in under-regulated and under-supervised financial systems, which put short-term financial rewards before companies' stability and risk evaluation. A package of measures is necessary to deal with the regulation and supervision of financial institutions, pre-contractual information and financial advice, responsible lending, deposit guarantee schemes, corporate governance, legislation on financial intermediaries and collective redress.

In the course of 2008, BEUC members prepared a response to the crisis, focusing on unified (rather than sectoral) supervisors in each Member State with expanded powers, improved cooperation between national supervisors and regulators, a financial supervision authority in charge of control of financial institutions operating at cross-border level, and binding rules at EU level rather than self-regulation.

Clear information for consumers about financial products is also essential, including honest information about levels of risk. Consumers need improved access to genuinely independent financial advice, better regulation of credit with more responsible lending, robust cross-border deposit guarantee schemes, and improved redress, both at the cross-border and national level.

Switching bank accounts

Consumers must be able to move their bank accounts without unreasonable costs and delays if there is to be a competitive market. We took part in the discussions hosted by the Commission on a voluntary code of conduct on banking mobility. We have some reservations about the outcome and will be closely monitoring its implementation.

Financial inclusion

BEUC believes that basic banking services should be available and accessible to consumers throughout the EU. We took part in the Commission's conference on financial inclusion in May.

Payments

BEUC wants better payment systems to be available for consumers, both for domestic and cross-border transactions. We participated in the Payment Services Group, the implementation group for the Payment Services Directive and the European Payment Council (Single Euro Payment Area). We particularly want to see improvements on direct debits and payment cards.

Consumer credit

Consumers need credit both for acquiring goods or their home. The financial crisis clearly shows problems consumers have to face in case of irresponsible lending and when they have been sold risky products. This is why BEUC has been very active during the last stage of adoption of the Directive on Consumer Credit. As well as briefing MEPs, we put forward views on the need to safeguard consumers in any agreement on cross-border exchange of credit data. We continue to monitor developments on the issues covered by the Commission's White Paper on Mortgage Credit.

Competition policy

Computer chips are a significant element of computers and their cost directly impacts on the final price paid by consumers. BEUC therefore intervened in the competition case arising from complaints against Intel from AMD, to ensure that consumer interests are fully taken into account in competition policy in general and in its enforcement in the computer sector in particular.

We also raised concerns with the Commission about the merger of DoubleClick and Google, monitored the Google/Yahoo deal, and provided input to the Commission inquiry into the pharmaceutical sector.

Energy and consumers

Just over a year after energy liberalisation, BEUC decided to investigate whether European energy markets are working better for consumers. In October we issued the results of our survey. BEUC members continue to report on problems faced by consumers in the electricity and gas markets, including in areas such as security and quality of supply, affordability and access, billing, choice and information.

We welcomed progress towards separating the ownership of electricity production from that of its distribution (full ownership unbundling) as a key element for making the EU market more competitive. The next step must be to tackle concentration in Europe's electricity markets. We have continued to press for improved rights for energy consumers in discussions on the Energy Charter.

Mobile phone roaming

We were delighted that the proposals produced by Commissioner Reding following the review of the current voice Roaming Regulation reflect the views put forward by BEUC during the consultation. BEUC wants to see the Regulation continued, with the addition of SMS and data roaming to its scope.

Mobile termination rates

Through high termination charges European telecommunications companies have been able to build their networks and provide cheap hand-sets. Time has come to decrease these charges so that consumers are charged less and that smaller operators can develop innovative services. We thus welcomed the Recommendation by the Commission to provide guidance to national regulators, to bring charges in line with the actual costs and look forward to its adoption in 2009.

Telecom package

BEUC worked intensively on the reform of the European Telecommunications sector as our members receive many complaints in this area. Consumers still suffer from complicated information, difficulties in switching, tie-in into long, expensive contracts or long-waiting periods to keep their old telephone number. Consumers must be informed by their Internet service provider or any web company if a breach of security puts their personal data at risk. Increased protection against unsolicited emails (spam) is also essential, as well as access to services, and of course protection from the so-called graduated response.

Safety and the Environment

Toy safety

Parents are entitled to expect that toys sold in the EU are safe. The new Directive agreed at the end of 2008 will bring some improvements to the safety of children in Europe: toys in food will be more strictly regulated, dangerous substances such as carcinogens will be banned and warnings on toys will be more visible and understandable. Unfortunately, hormone disrupting chemicals will still be allowed in toys despite the potential risks to children's health, and most toys will still not have to be checked by an independent third-party before being placed on the market.

Safety and the Internal Market

We have continued to be involved in discussions on the Commission's proposals on the Internal Market Package for Goods. Together with ANEC, we also raised concerns about the proposed European safety mark for consumer products including the lack of clarity over its potential use. We underlined the need for effective legislation, standards, market surveillance and enforcement.

Dangerous substances

BEUC continued to call on the Commission to issue a Green Paper addressing domestic pollution and in particular the effect of consumer products on air quality. We urged that the most dangerous chemicals should be prohibited or strictly limited.

Cosmetics

BEUC welcomed the Commission's proposal for a new Regulation on Cosmetics but regretted that it was not strengthened to prevent the use of carcinogenic, mutagenic and reprotoxic substances and to address our concerns including the use of nanoparticles in cosmetics, environmentally dangerous substances and misleading claims and marketing.



So far the European Parliament has done good work to ensure that the Directive is improved with regard to any claims made, but also the use of nanomaterials, calling for strict regulation and labelling in the list of ingredients of a product. Consumers would then be able to choose whether or not they wish to buy products that use this technology.

Nanotechnology

Nanotechnologies are a range of technologies that use materials on an incredibly small scale. One nanometre is a millionth of a millimetre. Materials at this small scale present different properties compared to "bigger" particles (eg: greater reactivity and mobility in the human body) and are increasingly being used to create new products or applications. Nanomaterials are already used in various products available on the EU market such as food, cosmetics, textiles, electric appliances and medicines. In the cosmetic sector, some manufacturers use nanomaterials to produce a sunscreen that is clear, rather than white when it is applied, or to produce anti-ageing creams which are claimed to be more efficient.

We acknowledge that nanotechnolgies have a potential to offer benefits. They could be used to improve the resource and energy efficiency of appliances, the storage capacity and loading time of batteries, or lead to new medical treatment opportunities. These technologies and materials may also present new risks which have never been evaluated. We are concerned about the increasing number of products containing nanomaterials which are already sold on the EU market without having been subject to a proper safety assessment.

The Commission has adopted a code of conduct in the field of nanotechnology research, intended to establish some guidelines in this research area. BEUC is concerned that compliance is only voluntary and we are calling for further regulatory measures to be taken as soon as possible in order to protect consumers' health and the environment, particularly for food and cosmetic products.

We participated in the 2nd Annual Nanotechnology "Safety for Success" Dialogue Workshop organised by DG SANCO in October 2008 and presented our expectations from and concerns about the use of nanotechnologies.

Sustainable production and consumption

BEUC works to help make sure that consumer products are as sustainable as possible and accessible for all. We want to see an EU-wide strategy to help consumers to make the right choices for a sustainable economy, balancing positive incentives, voluntary action and regulatory goals to bring real change. We found the Commission's Action Plan on Sustainable Consumption and Production and on Sustainable Industrial Policy rather unambitious, focusing largely on changes to existing measures.

We participated in a wide range of forums and projects, including Green Week, the Ecodesign stakeholder consortium project, the EU Ecolabelling Board, the stakeholder Consultation Forum on Eco-design and the new Retail Forum. We also took part in technical discussions on environmental aspects of products as varied as boilers, water heaters, domestic lighting, televisions, dishwashers, washing machines, refrigerators and freezers. In this context, we closely cooperate with our sister organisation ANEC.

We have also promoted choice editing, intended to ensure that non-sustainable or less sustainable products disappear from the market and are replaced by a broad range of sustainable products and services in all price ranges.

We lobbied for changes to the EU Energy Labelling Directive, the Eco-design of Energyusing Products Directive (together with ANEC) and the Ecolabel Regulation, and worked on the issue of 'green' electricity during discussions on the Renewable Energy Directive.

CO2 emissions from cars

The Commission proposal for a Regulation setting emission performance standards for new passenger cars sets unambitious targets for car emission levels and lacks strong measures to ensure car manufacturers' compliance. We called for changes, and also for a revision of the Car Labelling Directive to ensure that the label is harmonised across the EU and can be easily used by consumers.

Food

Nutrition

Promoting healthy nutrition and the fight against obesity are a high priority for BEUC. We again participated in the Commission's Platform on diet, physical activity and health and met with the Council, Commission, MEPs, EFSA and a wide range of organisations on issues such as the marketing of unhealthy foods to children, the provision of food information to consumers (including nutrition labelling), banning of artificial transfats, nutrient profiling and health claims.


Food Information

BEUC works to ensure that the information on food labels is clear, readable and easily understandable for consumers. It is urgent that the EU takes action to allow consumers to make healthier food choices. Research shows that consumers want mandatory information on a limited number of nutrients on the front of pack to help them make their purchasing decisions. The majority of consumers want this limited information to be complimented by a more detailed mandatory nutrient declaration on the back of the pack. The available evidence has shown that consumers prefer nutrition information on the front of pack to be expressed through the use of an interpretative element, namely multiple colour coding as it helps them to quickly and easily make informed food choices.

BEUC met with the Commission, Council Representatives and MEPs to present the consumer view on the Commission proposal. We also joined forces with the European Heart Network and European Public Health Alliance to call on MEPs to support the use of an interpretative element, namely multiple colour coding on the front of pack.

Food additives, flavourings and enzymes

BEUC has always tried to make sure that additives are safe, and that they are only used where they are necessary, do not mislead and provide a benefit to consumers. We again stressed these principles during the debate on Commission proposals on food additives and we also called for additive approval procedures to take account of the precautionary principle.



We joined with other leading EU organisations in a call on the European Commission to suspend the use of food colourings that affect the activity level and attention span of children.

Animal cloning

Surprisingly, there is currently no EU legislation dealing with products derived from cloned animals and their offspring. We welcomed initiatives by the Commission to stimulate a debate in this area and we challenged the draft position of the European Food Safety Authority on cloning. BEUC believes that animal cloning for the food supply is unnecessary for food security, food safety or to improve breeds of animals, and that it also raises issues of animal welfare. If cloning for food purposes were to take place, then full labelling would be essential.

Novel Food

In the course of 2008 the EU institutions discussed a proposal on novel foods. Novel foods such as sterols (e.g. used in yellow fat spreads) to lower blood cholesterol levels, lycopene (e.g. used in soups), for which it is claimed that it may help prevent certain cancers, and salatrims used in reduced fat bakery products and confectionary must be safe and offer benefits to consumers to be allowed on the market. There should be no danger to consumers' health should consumers ingest combinations of novel foods. Novel foods should be clearly labelled, so that consumers can make well-informed choices.

In November, we issued a specific position paper on nanotechnologies in food, providing comments on the draft opinion of EFSA's Scientific Committee on the potential risks arising from nanoscience and nanotechnologies on food and feed safety.

Chlorinated chickens

The EU's approach to food hygiene – which we support and which has been largely successful - is to try and eliminate as far as possible zoonotic infections such as salmonella in the food chain. The US approach for poultry, however, is to use antimicrobial treatments (AMT) which have worked less well. We joined with the European Environmental Bureau and COPA-COGECA, the EU farm lobby group, to oppose changes which would have allowed imports of AMT chlorine-treated chicken into the EU. We also raised this issue in the TACD and the Trans Atlantic Economic Council.

Other food activities


We took part in the High Level Group on the competitiveness of the food industry which will report in 2009. We began work as a partner in the project on policy options for marketing food and beverages to children (POL-MARK). We put forward views on the consumer interest in aquaculture. We also monitored developments with regard to nutrition information in restaurants and food hygiene legislation simplification.

Health

Cross-border health care

Patients prefer to be treated close to their home and family and they must be entitled to receive the best available care in their own country. When this is not possible or when they choose to seek health care in another Member State, they must have the rights to do so, be aware of those rights and have the means to enforce them.

We therefore welcomed the Commission's proposal for a Directive on Cross-border Health Care. It is high time that patients had legal certainty in this area and the fullest information in order to make rational choices. We particularly welcome the proposed establishment of national contact points that will provide patients with information on essential aspects of cross border health care, including procedures, reimbursements, and means of redress where problems arise.

However, further discussions are needed on the system for prior authorization for hospital care: it must not lead to confusion and increased inequalities between the Member States.

Pharmaceuticals

Consumers need impartial information about prescription medicines, not disguised advertising.

We strongly criticised the moves by DG Enterprise to amend, as part of the pharmaceutical package review, the Directive on Medicines in order to allow pharmaceutical companies to communicate directly to the general public on their prescription-only medicines under the guise of 'patient information'. BEUC especially criticised the risk of potential confusion between advertising and objective information and joined with patients, healthcare, community pharmacists and other organisations in a call to the Council and Parliament to reject these proposals.

We welcomed the Commission proposal to strengthen the pharmacovigilance system, and in particular the introduction of the possibility for consumers to report side effects directly to the competent authorities. Finally we welcomed the Commission proposal against falsified medicines as a necessary step to better protect consumers and we called for stronger measures against illegal Internet sales.

Other health issues

BEUC has also been involved in discussions on E-health patient safety, in the European Medicines Agency (EMEA) initiative on the readability of medicine information leaflets and in the DG Competition pharmaceutical sector inquiry.
